Explanation of Responses:

- Each restricted stock unit represents a contingent right to receive one share of Unisys Corporation common stock.
- Time-based restricted stock units granted under the terms of the Unisys Corporation 2010 Long-Term Incentive and Equity Compensation Plan. The restricted stock units vest in three equal installments beginning April 20, 2017.
- Each restricted stock unit represents a contingent right to receive 0.959 shares of Unisys Corporation common stock.
- Performance-based restricted stock units ("PB-RSUs") granted on April 20, 2016 under the Unisys 2010 Long-Term Incentive and Equity Compensation Plan. The PB-RSUs are earned one-third annually over a three-year period to the extent Unisys Corporation achieves a performance goal relating to the operating profit for that year in each of 2016, 2017 and 2018, respectively, and then such earned PB-RSUs vest on April 20, 2017, 2018 and 2019. This report only relates to the PB-RSUs the reporting person earned based on the 2016 performance goal. All shares resulting from such earned PB-RSUs vest on April 20, 2017.
